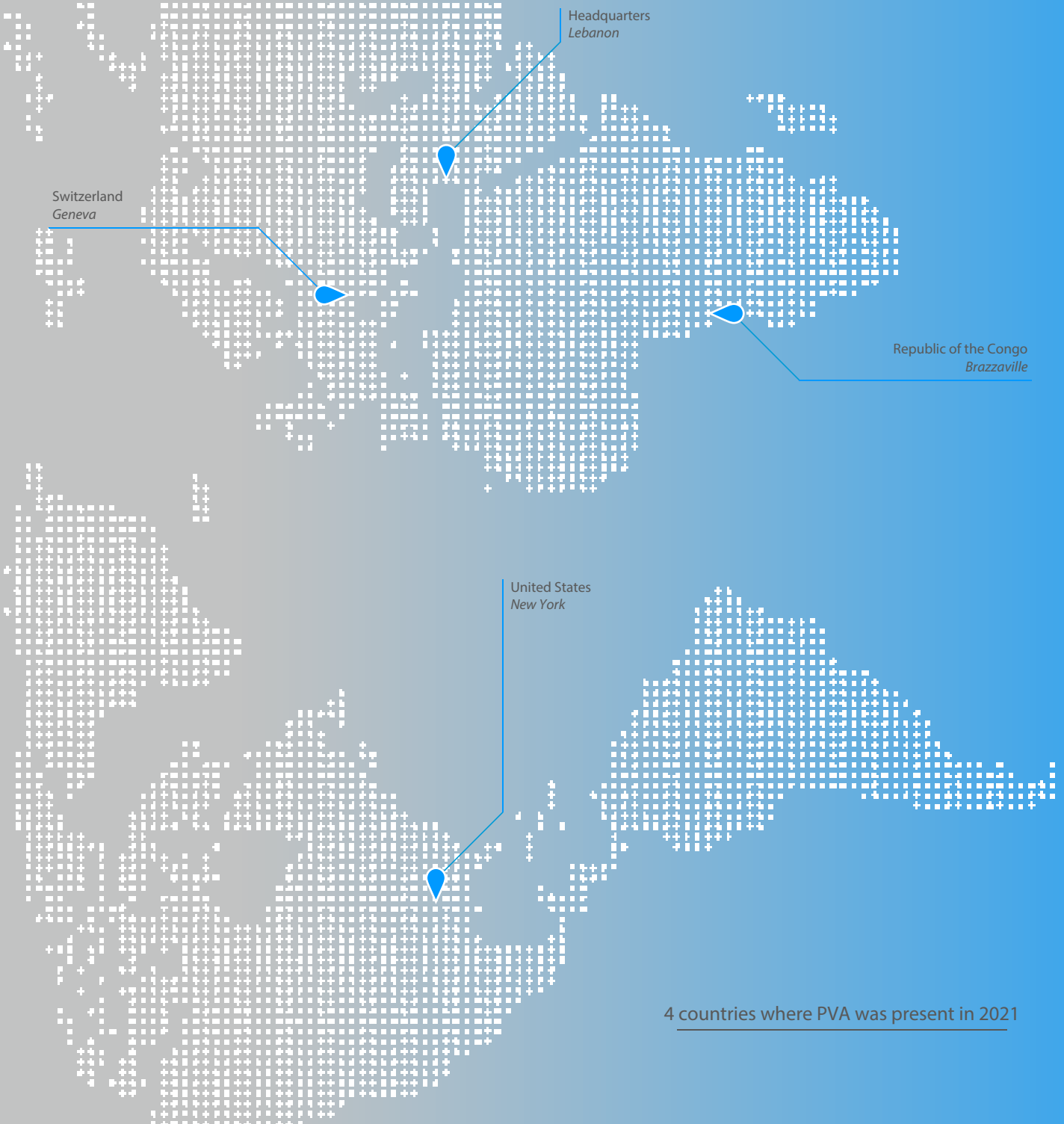

# Open Letter

## Word from the president

The COVID-19 pandemic dominated the past year across the globe. It is no surprise therefore that 2020 and 2021 set new records for the numbers of people requiring humanitarian aid and support. Results include improved well-being of the most marginalized people and communities, improved awareness and positive changes in behavior towards protection of children and driving these changes in communities.

Overall, in partnership with partners from governments, UN, NGOs, CSOs, private sectors, donors, academia, and of other actors, PVA reached out to more than 40,175 direct and 208,392 indirect beneficiaries in 2021.

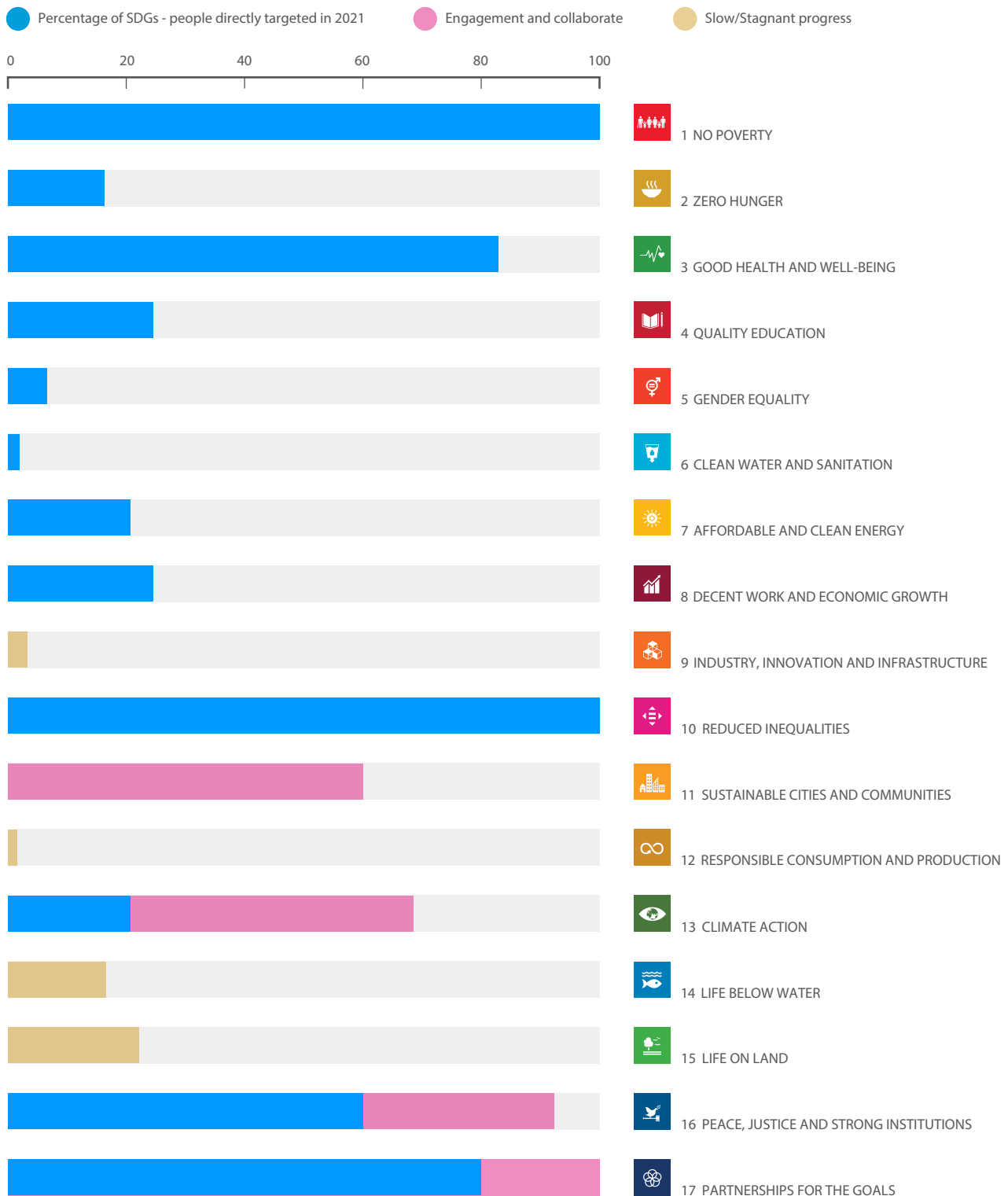

# STRATEGIC OBJECTIVE 1

To make certain that food is available and everyone everywhere able to have reliable access to the food they need and are able to utilize it to live active and healthy lives.



# Food Security and Nutrition

## Context

Disasters, whether natural or human made, often lead to food insecurity. Approximately 821 million people, or just over one in nine, live in hunger. Poor nutrition is an underlying cause of nearly 2.4 million childhood deaths each year. Food assistance saves lives by addressing the most direct and immediate forms of food insecurity, while enhancing livelihoods, improving health and education, and empowering communities to build a hunger-free world.

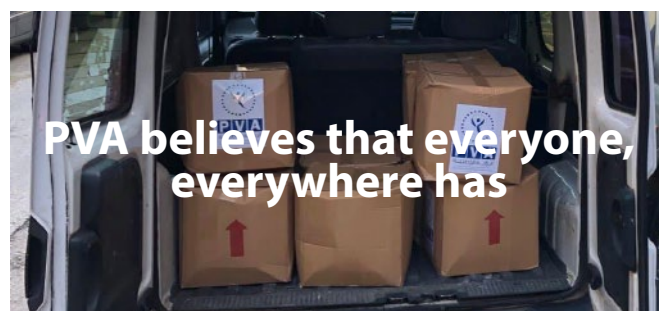
The COVID-19 pandemic has extended into 2021 and marked by enormous challenges. The situation changed dramatically. Food price increases and the economic crisis, compounded by the effects of the pandemic, affected all population groups, with the most marginalized hit the hardest. As COVID-19 pandemic remain, the further deterioration of the situation threatens to push many more into poverty and food insecurity. These shocks have reversed decades of progress against poverty, inequality and food insecurity, and threaten the achievement of the UN 2030 Agenda for Sustainable Development.

## Key objectives

PVA believes that everyone, everywhere has the right to have enough nutritious food each day to live a healthy life, and a hunger-free world is possible.

When crisis disrupt people's ability to earn livelihoods as what is happening now during the COVID-19 pandemic, or when conflict disrupt markets, or where markets are available, but food is unaffordable, or when babies are acutely malnourished or persons are living with severe illnesses, PVA deliver emergency food relief and empower them to build food security and resilience, giving them choice, and dignity and diversified diets.

To ensure children and families do not have to go to bed hungry, PVA provides life-saving food assistance, extra nutritional supplements, sustenance and stability to communities, schools and vulnerable groups. Vulnerable group feedings ensure the least of these are prioritized first to build a hunger-free future. Meeting immediate food needs helps free vulnerable households from having to devote their time and energy to securing the most basic components of their diet and helps ensure they have the means to invest in making their farms more productive, their meals more nutritious, and their children more highly educated, cared for and protected. PVA food security and nutrition programs are boosting the local economy, while giving families, choice, and dignity and diversified diets.



## Key outcomes

In 2021, PVA responded to the needs of nearly 3,100 vulnerable people both from host communities and migrant/refugee with special focus on female headed households, widowed women, and households with more than 4 children, by providing relief food, and 1,000 vulnerable people have benefited through Multi-Purpose Cash Assistance (MPCA) to cover other basic food needs. This was done in 6 phases, each phase was distributed after a period of 2 months than the previous one. Each food parcel was enough to feed each household for 2 months. Each food parcel has been prepared with a focus on the nutritional aspect, as each parcel differs in some food items from the previous one.

The Nutrition Sector emergency response plan addressed unmet/emerging nutrition vulnerabilities and needs among over 1,200 of both host communities and Migrant/refugee population through protect, promote and support the uptake of recommended maternal, infant and young child feeding, pregnant/lactating women and care takers of children aged below 2 years, and by insuring milk and other essential nutrition items for vulnerable pregnant and lactating women and U5 children.

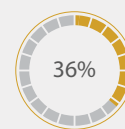

# STRATEGIC OBJECTIVE 2

Ensure access to life-saving and life-sustaining health services - Follow the pillars approach laid out in the WHO global Strategic Preparedness and Response Plan for COVID-19.

# Health Assistance and COVID-19

## Context

The current economic crisis, coupled with the COVID-19 pandemic, has impacted both the health system and patients themselves. Poor, uninsured families in need of hospitalization face demands for significant financial deposits to secure admission. Without cash, desperate patients are forced to sell assets, borrow funds at unfavorable rates or delay or forgo care. At the same time, scarcity and unaffordability of medicines – particularly those used to manage non-communicable diseases (NCDs) such as hypertension and diabetes – are resulting in increased hospitalization among these patients. Additional cost barriers are common, including COVID-19 care, COVID-19 PCR tests and costs of personal protective equipment (PPE).

As the higher income countries across the world look to move on from the pandemic, the world's most vulnerable are still battling dangerous increases in cases and feeling its effects. Furthermore, the high cost of COVID-19 Hygiene kits, Infection, Prevention and Control (IPC) kits, will further target vulnerable communities and schools with resource challenges.



## Key objectives

PVA main health interventions in 2021 consisted of following the pillars approach laid out in the WHO global Strategic Preparedness and Response Plan for COVID-19, with particular emphasis on supporting case management of COVID-19 cases, strengthening the response of the public health system to reduce the transmission by providing free testing, case detection, isolation and referral services, supporting the healthcare frontline workers, supporting schools for a safe return to education, increasing needs of the communities, assisting affected families, including assistance in building or rehabilitating health facilities in rural areas, responding to misinformation, promoting awareness and healthy hygiene practices to ensure children and their families know how to protect themselves and how to seek assistance.

Providing Primary Health Care (PHC) by ensure access to life-saving and life-sustaining health services for those most vulnerable and in need in the context of worsening socio-economic conditions, ensuring child and maternal health, supply of additional medicines and unavailable medicines in the country for acute, chronic, reproductive, mental and catastrophic health conditions, supporting health facilities in rural areas to ensure continued access to emergency and critical care with an emphasis on both host communities and migrant/refugee patients, and persons with disability. PVA will continue to support the public healthcare system and other front-line entities assisting at-risk population, and we work with partners and donors to expand our support and ensure its funding.

## Key outcomes

In 2021, PVA has procured more than 80 percent of its COVID-19 supplies from local suppliers to support the local economy and 20 percent from donating partners, which included: Personal Protection Equipment (PPE) kits, Infection, Prevention and Control (IPC) kits, this includes pairs of gloves, surgical masks, N95 masks, COVID-19 tests, alcohol disinfectant, medical cotton wool, hand sanitizer, tissue paper, waste bags, among other health items, and have been distributed and delivered to support over 580 healthcare and other frontline workers in 3 municipalities, 8 CSOs, 2 civil defense; more than 7,000 population at risk; nearly 11,400 students, teachers, and school staff in 10 schools; and over 2,500 of other partners/actors.

In parallel, PVA provided medicines "shipping and free distribution of unavailable medicines" to 592 people, and 408 people have benefited through Multi-Purpose Cash Assistance (MPCA) to cover medical treatment and health services. In addition, PVA helped build one health facility in a rural area, which has a population of 7,500.

PVA also supported the United Nations campaigns in particular responding to misinformation and awareness raising of COVID-19 that have reached millions of people via TV channels, social media platforms, radios and on the ground to strengthen their knowledge and skills on the prevention measures, self-isolation and protection of sick people.

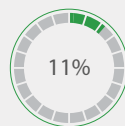

# STRATEGIC OBJECTIVE 3

Direct support to vulnerable children to ensure continued learning - Holistic and integrated Child Protection services to boys and girls at risk of violence, abuse and exploitation.



# Education and Child Protection

## Context

Millions of school-age children have had their education disrupted in 2020 alone, with thousands of children being left out of school as a result of poverty, the economic crisis, COVID-19 and other factors. These children are at greater risk for exploitation, child labour, child marriage, and lower income-earning potential. The economic crisis is forcing families, particularly the most vulnerable and migrant/refugee households, to adapt their livelihood-related coping strategies. Meanwhile, the cost of education has increased with many families unable to afford textbooks, stationery or IT equipment for online learning. Such acute shifts in student demographics seriously compromise the capacity of the school system to ensure basic conditions, to provide relevant, inclusive, and quality education.

In parallel, the current economic situation and COVID-19 pandemic has put children and especially girls at greater risk of abuse, violence and exploitation. Moreover, Child Protection sector's reporting analysis shows the increased needs of Child Protection services. In addition, increased levels of debt and difficulties in paying rent or purchasing basic items have exposed vulnerable families and other marginalized individuals to various forms of violence, also increasing the risk of harmful coping mechanisms such as child marriage and child labour - which can lead to exposure to violence and/or abuse and exploitation.

## Key objectives

PVA main aim is to ensure that the most vulnerable children and students affected by the economic crisis and COVID-19 are reached and provided relevant, inclusive and quality education adhering to national and international standards on education in emergencies. This is achieved by providing support to both children and parents, PVA will use a combination of modalities which range from joint assessments, community-based support through outreach and awareness, school-based support, and direct beneficiary level support through cash, remote learning, and ensuring their wellbeing and accessibility.

Holistic and integrated Child Protection services are provided to boys and girls at risk and/or survivors of violence, abuse and exploitation through PVA Child Protection Policy. The main interventions will include; Integrated Child Protection case management services, Social and behavioral change initiatives, and Emergency protection cash assistance, by ensuring that schools have basic conditions despite the challenges faced due to COVID-19. PVA will also focus on specific outreach activities that will be tailored to the different needs of the target groups, including establishing/strengthening community based child protection and GBV networks and

focal points. Women and girls, in all their diversity, will be engaged as active partners to prevent, mitigate, and respond to GBV.



## Key outcomes

In 2021, PVA has contributed to safe access to quality and inclusive education of the most vulnerable boys and girls. This has been done through providing Multi-Purpose Cash Assistance (MPCA) to almost 1,000 children and youth to cover their scholarships, low-cost solutions (both low-tech and high-tech) for inclusive remote learning, procurement of stationery packages and other school / university fees. Provision of assistive technologies and COVID-19 personal protective equipment (PPE) kits and Prevention and Control (IPC) kits to 10 schools of nearly 11,400 students, teachers, and staff to enable student access and retention in education.

In parallel, PVA continued to empower children, teachers, parents, caregivers, and community leaders by promoting Child Protection Policy and SDGs. In addition, specialized child protection services have been provided, advocacy to eliminate modern slavery especially child labour, capacity development of school personnel and teachers on Child Protection Policy, promoting and applying SGBV risk reduction in adapted learning programs through raising awareness amongst children and caregivers on violence, bullying, cyber bullying, online safety.

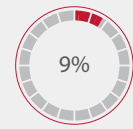

# STRATEGIC OBJECTIVE 4

Provide Non-Food Items (NFIs) and provision of multi-sectoral logistic assistance - Cover essential and sudden needs of families and ensure humanitarian gaps are covered.



# Non-Food Items (NFIs) and Logistics

## Context

The multiple crises afflicting our world have led to a severe deterioration in people's standard of living. Basic rights are being denied as people are unable to afford or access basic goods and services. Extreme poverty increased three-fold from 2019 to 2020. In parallel, refugee families (nine out of ten) live in extreme poverty, with even worse conditions for female-headed households. As the situation continues to deteriorate, an even greater number of people is falling into absolute poverty.

In parallel, the situation has affected the availability of basic services and an increasing number of individuals are seeking to access of basic services such as fuel, electricity, gas, winter assistance, and other Non-Food Items (NFIs) and logistics. If the situation remains the same and reforms are not implemented, the potential for further deterioration and social tensions will continue to increase. Such a trend will ultimately further increase the number of people in need of acute humanitarian assistance.



## Key objectives

PVA aims to provide Non-Food Items and multi-sectoral logistic assistance to people in need to deepen our commitment to the most vulnerable communities. Sectoral and inter sectoral coordination will be key to ensuring that humanitarian assistance reaches those most in need with a focus on the most vulnerable communities and households. Particular emphasis will be placed on the most vulnerable and at-risk groups including children, women, the elderly, people living with disabilities or who are chronically ill.

PVA will strive to contribute to the achievement of three key objectives in 2021: i) Save lives and alleviate the suffering of the most vulnerable people; ii) Enhance the prevention, mitigation and response to protection needs; and iii) Increase resilience, livelihoods and access to basic services. We ensure that those affected by disasters are involved from the beginning and work with communities and local authorities to build back better and increase their resilience to future disasters.



## Key outcomes

In 2021, PVA implemented projects focused on assisting crisis-affected communities through the provision of Non-Food Items (NFIs) and multi-sectoral logistical assistance. These included;

i) Winter relief kits; mattresses, winter clothing, tarpaulin, electric heated blanket, blankets (king size, double size, twin size, and crib size) were consistently supported as top NFI needs in 2021 to support vulnerable families to cope with the bitter cold.

ii) In addition to winter relief kits, gas for cooking, gas for heating, winter heaters were frequently delivered among needs and as items that households would purchase if given cash or cash vouchers.

iii) In addition, portable light sources (rechargeable lamps + flashlight, emergency rechargeable bulb, and solar lamps) to increase access services to families located in areas without regular access to power, as ensuring access to electricity and lighting is crucial, and lack of electricity may have a serious impact on health conditions of people and on children's education.

iv) Multi-Purpose Cash Assistance (MPCA) and fuel assistance to the most vulnerable families and workers in rural areas to be able to access to basic needs and other winterization items.

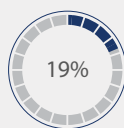

# STRATEGIC OBJECTIVE 5

Contribute to saving lives, reducing suffering, and increasing the dignity of crisis-affected the most vulnerable families through cash-based interventions.

# Cash-Based Interventions

## Context

For the past several decades, the assistance strategies of humanitarian organizations such as Patriotic Vision PVA have focused on providing goods and services needed by disaster-affected populations to meet their basic needs and rebuild their livelihoods. Reduced food access is addressed by the distribution of food; loss of basic goods is met with distribution of non-food items (NFIs); destroyed or damaged houses are replaced with temporary shelters while building materials are distributed, and lost livelihood assets are made up for with a distribution of seeds, tools, animals and other items. Many organizations have systematically begun exploring the use of cash as an alternative way of transferring resources, enabling people to purchase the goods and services that they most need.

Cash transfers are not just another way of delivering aid. They are transforming the way we do humanitarian assistance, maximizing achievements, helping to build resilience, while relying on a limited number of resources. In leveraging Cash and Voucher Assistance can we truly transition these families from moments of desperation to a vision of hope. Beneficiaries can have the choice and dignity they deserve for a brighter future.

## Key objectives

Patriotic Vision PVA has committed itself to increasing the evidence on the use of cash transfers in emergency programming, and to learning how best to utilize cash when and where it is appropriate. Patriotic Vision PVA set up an internal working group to guide a process of research and action learning on cash transfers as a way to provide emergency relief, and its implications for PVA programming. A particular focus has been placed on developing methodologies to enable PVA to make more informed decisions about the use of cash transfers as alternative or complementary mechanisms in different contexts.

Patriotic Vision PVA took a strategic decision to deepen our commitment to the most vulnerable communities through cash-based interventions that are aimed at meeting immediate needs and assisting vulnerable families to recover adapt and create sustainable livelihoods.

Building on 10 years of experience in cash programming, cash assistance is used for a wide range of purposes including protection, basic needs, education, shelter, health, and livelihoods. Beyond the monetization of assistance, it is also actively used as a vehicle to further solutions, with cash being an enabler for financial inclusion, social protection, social cohesion and self-reliance.



## Key outcomes

Throughout 2021, 95% of direct beneficiaries of cash-based interventions, most of which were related to Multi-Purpose Cash Assistance (MPCA) within PVA projects and programs, reported that cash-based interventions improved their living conditions and helped reduce feelings of stress.

A large part of PVA 2021 cash-based interventions was dedicated to achieving specific outcomes, including in the COVID-19 response and the current economic crises. The most common support through cash was helping vulnerable families from financial catastrophe, GBV prevention and response, unlocking better access to basic services in a manner that enables them to make decisions about their own welfare in ways that in-kind assistance does not. Cash-based interventions was also alleviate debilitating stress, which can lead to violence and poor mental health.

Cash was also actively used through Multi-Purpose Cash Assistance (MPCA) to achieve outcomes in the areas of PVA 2021 projects of food security and nutrition, enabling access to health, education and child protection, non-food items (NFIs) and logistics, and livelihoods.

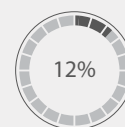

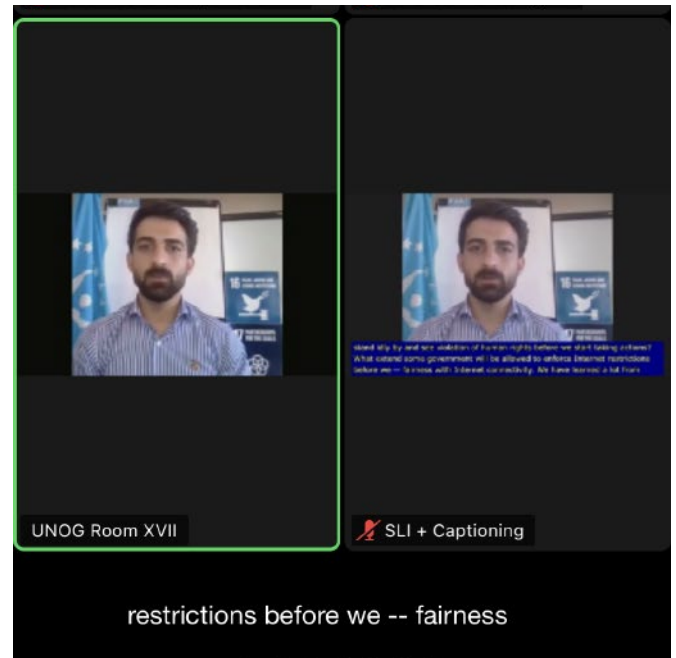
# United Nations Engagement

## Context

NGOs have become increasingly influential in world affairs, the World Bank estimates that over 15% of total overseas development aid is channeled through NGOs. Many of the largest, most significant NGOs have relationships or official associative status with intergovernmental organizations such as the United Nations.

The basis for the consultative relationship between the UN and NGOs is the original Charter of the UN. Article 71 says that the Economic and Social Council “may make suitable arrangements for consultation with NGOs which are concerned with matters within its competence.” NGOs contribute to the work of the UN by providing technical analysis and expertise, and their relationship with offices and agencies of the UN system differs depending on their goals. This relationship is the principal means through which ECOSOC receives input from NGOs into its deliberations at public meetings as well as in UN international conferences and their preparatory meetings.

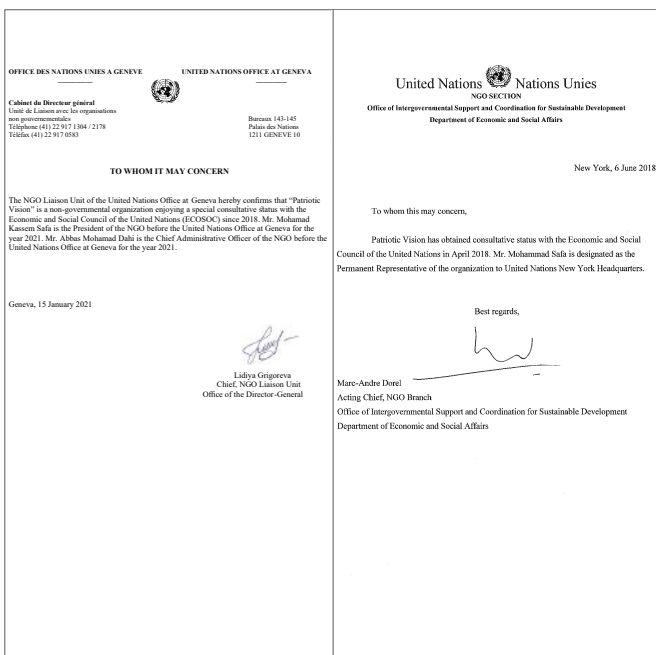
Patriotic Vision PVA was granted special consultative status with the UN Economic and Social Council (ECOSOC) in 2018. An NGO in consultative status with ECOSOC is obligated to uphold principles it agreed to follow when it was granted status. In practical terms, this allows NGOs with consultative status to share in the follow-up and implementation of major international conferences, network with other NGOs, and ensure that their goals and concerns are brought before the international community.



## Key objectives

PVA delegations to the United Nations operate in many countries including (New York, Geneva, Vienna...) works aims to strengthen collaborations with the Office of the UN Economic and Social Council, UN High Commissioner for Human Rights, UN Human Rights Council, UN Department of Global Communications, and various UN bodies and agencies, on influences discussions, decisions and providing information on the human rights situation in countries, in order to connect policy with practice to achieve the fulfilment of the rights of the most vulnerable people of this world. It also aims to foster research, focusing on the areas of social accountability, sustainable development goals and agenda 2030, campaigns, governance and policy formulation.

PVA representatives to the UN focus on areas as rights at the center of sustainable development, peace, humanitarian affairs, rights in times of crisis, gender equality, public participation, child protection, climate actions, rights at the heart of collective action, and new frontiers of human rights and sustainable economic development. We believe all people should be valued, listened to, included and nurtured within peaceful, reconciled and equal families, communities and societies. We strives to ensure that everyone can exercise the right to life and to live in freedom and safety, and to be equal in dignity and rights, and can claim their rights regardless of sex, race, language, religion, social standing, etc.





## Key outcomes

In 2021, our efforts were aimed to strengthening cooperation with the United Nations and to amplify the voices of the unheard through advocacy, global campaigns and conferences:

- 9th edition of the Geneva PeaceTalks, Tuesday 21 Sep 2021, under the theme of “Recovering Better for an Equitable and Sustainable World”.
- 20th anniversary of the adoption of the Durban Declaration and Programme of Action, 22 Sep 2021, on the theme “Reparations, racial justice and equality for people of African descent.”
- UN High-Level Event on Peace, Diversity and Our Common Humanity, 4-5 Oct 2021.
- UN 2021 Social Forum, 11 and 12 Oct, focused on “good practices, success stories, lessons learned and challenges in the fight against COVID-19”.
- Responding to Various UN global campaigns, such as take care before you share and fighting racism and such more through all our social media channels, messages, and TV programs.
- Working towards the UN Sustainable Development Goals (SDGs).

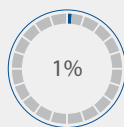

# STRATEGIC OBJECTIVE 7

Strengthening cooperation with governments, NGOs, INGOs and civil society organizations - Collaborating for broader impact on COVID-19 responses and UN Sustainable Development Goals.

## Collaborate - Governments, NGOs, CSOs

### Context

The COVID-19 global pandemic, the climate crisis, the gaps in achieving the UN 2030 agenda and the UN Sustainable Development Goals and increasing state fragility all pose massive challenges for society. Impactful partnerships, involving organizations from all sectors of society, are one necessary way of rising to these challenges. No organization or government working alone can solve the problems facing our world. PVA believes that only by working together with people, their communities, and our supporters and partners, the lives of the world's most vulnerable people can be transformed.

Organizations have different understandings of how to partner effectively which could lead to misalignment of expectations and poor partnership outcomes. Holding joint partnering training with potential partners can address these issues and build key partnering competencies including how to apply core partnering principles and effectively manage common challenges through the partnership management cycle.

The lives of children in all countries, but especially in the most dangerous contexts, can change for the better when organizations invest significantly in global campaigns with national expressions of that campaign that comprise diverse, equipped partners.

Working in partnership enables PVA to achieve greater impact than we ever could on our own.



### Key objectives

Collaborating and advocacy are also an essential element of our work. We empower communities to identify and address challenges in the policies, systems, structures, practices and attitudes that hinder their development. PVA's advocacy work ensures that community transformation is sustainable and scalable. We advocate with authority and confidence, using evidence rooted in our relationships with the people at the community level. The goal is to ensure that these efforts help to strengthen various systems and structures, including the allocation and utilization of resources that are required to improve the lives of people.

At every level – from a local community to global – PVA works with partners from across society to influence and bring our expertise and resource to transform people's lives. We value the role, expertise and resources of governments, businesses, civil societies, the private sector, donors, academia, non-governmental organization, and of other actors and networks in addressing the welfare of the people. We work to make our partnerships positive for every partner. This means we have a commitment to seek mutual benefit; to respect and values others' contributions; to manage power dynamics carefully; to listen and be responsive, and to communicate openly and transparently. We measure our partnering practice and make sure it is fully aligned to global humanitarian standards - Committed to, guided, and based on the United Nations Conventions.



## Key outcomes

In 2021, PVA engaged in a number of humanitarian, development, advocacy, and outreach activities with governments, CSOs and NGOs. Some of the initiatives PVA efforts contributed to included:

- Contribute for COVID-19 prevention and response in partnership with the Chinese Embassy.
- Collaborate with US CSOs to reach more families through PVA humanitarian projects.
- Cooperate with Lebanese MPs and ministers to improve the quality of governance and to serve their citizens through more transparent, accountable and participatory structures.
- Follow-up on PVA's office in Brazzaville, Congo, to expand PVA's work worldwide.
- Empowering schools and CSOs on Child Protection Policy.
- Cooperate with municipalities and NGOs to improve the quality of services and achieving the SDGs.

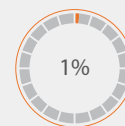

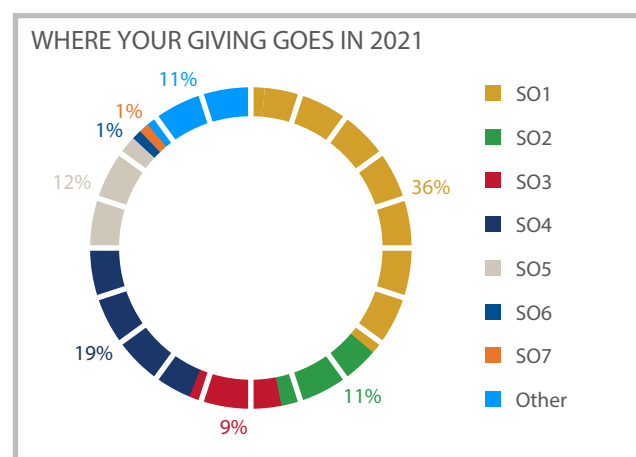
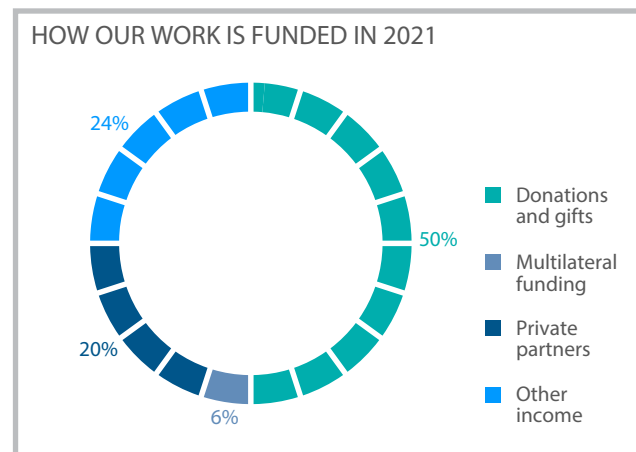
